## archi 2020 Activities & Accomplishments

#### **INNOVATOR** Innovations in Care Coordination

**Diabetes Collaborative**: Five health systems partnered to address the unmet social needs of diabetics and improve diabetes education. The first round of the pilot ended in the spring of 2020, demonstrating significant heath improvement for most patients.

82% of patients had a clinical reduction in A1c.

**62% of patients** lost weight.

64% of patients had a decrease in their blood pressure.

**76% of patients** reported improved eating habits, **56%** added an exercise routine. **27%** said they checked blood sugar more consistently, 22% increased their healthy food choices and 12% reported a reduction in the number or dose of their medications.

Patients were referred to over 40 legal, housing, transportation, nutrition, financial assistance. health and behavioral health providers.

### Forsyth County Status

- Forsyth County joined Atlanta Regional Commission July 1
  - This status does <u>not</u> apply to the area agency on aging (AAA) planning and service area (PSA)
  - PSA boundaries are designated by the Georgia Division of Aging Services (DAS)
  - Forsyth County must make request to DAS to start process
- ➤ A&IS Group meeting with Forsyth Senior Services to respond to their questions
- ➤ ARC is neutral on Forsyth County joining ARC AAA

## **ARC Office Reintegration**

- ➤ Phase II: Pilot (mid-July mid-August) to test office opening
- ➤ Phase III: Plan to begin in September
  - Staff return to office
  - Revised telework and remote work policy under development
  - Board and committees to meet in person (with virtual option)

## **ARC Office Reintegration: ACA Impact**

- > September 22 ACA meeting
  - In person (with virtual option)
  - Subject to Georgia Open Meetings Law: in-person needed for quorum and voting
  - No food served
  - No guests may attend in person (only virtually)
  - Safety precautions in meeting space (distancing, sanitization, etc.)
  - Masks optional for all, required if not vaccinated
