B. Georgia Mobility and Accessibility Planner (G-MAP) – A mobile app being developed as part of USDOT's ITS4US – Complete Trip Deployment Program

Jordan Hall (Statewide Independent Living Council of Georgia) and Kofi Wakhisi (ARC) will provide an overview of the Georgia Mobility and Accessibility Planner (G-MAP). G-MAP is a mobile trip planning app for users to receive customized turn-by-turn travel directions based on their specific disability or travel needs. The app will initially be deployed in Gwinnett County.

The ARC Board approved the 2020-2025 Live Beyond Expectations Strategic Framework, which focuses on disparities in life expectancy within our region, in 2020. Since then, the Aging & Independence Services Department has been taking a deep dive into better understanding 10 census tracts in our region with low life expectancy.

This presentation will:

- summarize what staff learned from the community engagement process;
- inform Board members how they can access more detailed county-level data; and
- invite Board members to be involved in next steps of identifying solutions and leveraging resources for these communities.
- B. Metropolitan River Protection Act (MRPA) Corridor Plan Amendment Update *Jim Santo*, Principal Planner, Natural Resources

Staff is proposing an additional amendment to the Chattahoochee Corridor Plan to exempt public water supply reservoir dams from the 35-foot height limit in the river 500-year floodplain currently required in the Plan. The additional amendment requires moving the vote on the Plan amendments to November to meet all the requirements of the amendment process. This presentation is to discuss the amendment and the revised timeline.
