


## What is the Area Plan on Aging?

- ARC is the "Area Agency on Aging" (AAA)
  - 10-county metro area
  - Designated by Georgia Division of Aging Services (DAS)
  - Required by US Administration for Community Living
- Every AAA submits a 4-year plan for delivery of aging services within its region
  - Required by the federal Older Americans Act
  - Georgia's plan contains state-determined goals, objectives, and measures
  - DAS requires an annual update from each AAA







## What is the FY 24 Area Plan on Aging <u>Update</u>?

- Application to the Georgia Division of Aging Services (DAS) for grant funding
  - One "multi-funded" grant made up of numerous federal and state aging services grants
  - For the State Fiscal Year (July 2023 June 2024)
  - Includes approval to receive COVID-related funds
- Reports ARC's progress on the Plan's goals and objectives


- Enables ARC to serve our region's older persons and people with disabilities
