### **Performance Measures Timeline**

Performance targets were established in MAP-21 Act (2012), and further supported in the FAST Act (2015) and recent IIJA legislation (2021) to ensure states and MPOs are meeting federal goals and requirements.

Target	Description	Update Schedule
PM 1	Safety	Annually
PM 2	Asset Management	Bi-annually
PM 3	System Performance/CMAQ	Bi-annually

Data is collected on an annual basis on all measures for both federal reporting and to check if states and MPOs are meeting their own targets.

## **PM 1 Safety Targets**


In accordance with guidance from the Regional Safety Strategy, ARC will support the statewide safety targets AND adopt its own targets.
