


#### **Local Government Sales Tax Definitions**

## **Collections / Returns**

Funds generated by consumers when purchasing taxable goods and services over a period of a month. Merchants are then responsible for submitting these funds to the Georgia Department of Revenue.

August collections occurred between August 1 and August 31)



#### **Distributions**

Funds returned from the Georgia Department of Revenue to local governments once adjustments are made to the collections submitted by merchants. Payments are generally available at or near the end of the following month.

Distributions based on August collections were made at the end of September.

\* September distributions were abnormally large for many jurisdictions following a DOR audit where it was determined that the share of sales tax revenues being returned to local governments over a period of several years was low due to a software error. Appropriate one-time adjustments were made in September to rectify the errors. 

### **Motor Fuel Tax Revenues**

\* The economic shutdown's impact on motor fuel tax collections during April, when the statewide shelter in place order was in place, was skewed due to large one-time settlements received as a result of routine Georgia Department of Revenue audit activities. Even though total vehicle miles of travel (VMT) for the month was only about 50% to 60% of normal pre-pandemic levels, motor fuel tax collections were 51% higher than April 2019.
