## **ARC Board Elects At-Large Citizen Members**

The ARC Board elected a new slate of at-large citizen members to join the board for terms beginning on January 1, 2021.

The elections are required following the adoption of updated at-large district boundary maps by members of the Georgia Legislature whose districts are wholly or in part of the ARC's 11-county area. The boundaries are revisited every 10 years, after the release of the U.S. Census population totals.

## ARC 2022 Work Plan Overview

Kevin Crump, Senior Director of ARC's Center for Strategic Operations and Administration, delivered a presentation about the agency's 2022 work plan. Crump provided a detailed list of work program highlights that included:

- Implementation of the Strategic Plan on Aging, "Live Beyond Expectations."
- Initiate a Community Stakeholder Equity Focus Group program to better understand the needs of the transportation disadvantaged.
- Begin work activities to conduct a new Household Travel Survey to better inform regional planning and model development.
- Prepare a Regional Safety Action Plan designed to improve safety conditions in the Atlanta region.
- Begin an update to the Regional Freight and Goods Movement plan.
- Launch a comprehensive strategic communications plan to support agency goals and objectives.
- Develop the Engaging Communities Strategic Framework to guide and support agency wide community engagement.
