Every four years, ARC must update the region's long-range Metropolitan Transportation (MTP) and develop a new short-range Transportation Improvement Program (TIP) covering the first four years of the MTP. The last MTP and TIP were approved in February 2020. The MTP maintains the current 2050 horizon year, while the TIP will be for FY 2024-2027. An overview of the process and draft plan contents will be provided as part of the first read of an approval resolution. Formal approval will be requested at the January 2024 meeting.

B. Metropolitan River Protection Act (MRPA) Corridor Plan Amendment Update *Jim Santo*, Principal Planner, Natural Resources

This action item is to amend the Chattahoochee Corridor Plan, which is administered by ARC and affected local governments under the Metropolitan River Protection Act. The proposed amendments were first presented at the August Board meeting and again in October after an additional amendment was proposed. The amendments are to allow public trails in the 500-foot buffer, to allow streambank restoration and to allow removal of invasive species with subsequent revegetation with native species and to exempt public water supply reservoir dams from the 35-foot height limit in the River floodplains.

C. 2023 Comprehensive Economic Development Strategy (CEDS) Annual Report Nicole Hendrickson, Chair, CRC Keri Stevens, ARC, Community Development

The Atlanta Regional Commission is the designated Economic Development District (EDD) by the Economic Development Administration (EDA). Federal regulations require ARC, as an EDD, to develop a Comprehensive Economic Development Strategy (CEDS) every five years (adopted in 2022) and provide an Annual Report approved by the ARC Board, including a resolution. The 2023





CEDS Annual Report outlines the implementation measures and successes. In addition to the Annual Report, a StoryMap has been created to highlight successes in the past year and outlines initiatives for next year. Here is the link: <u>bit.ly/CEDS-storymap</u>.

# D. 2024 Budget and Work Program Bob Reeves, Treasurer James Husserl, Chief Financial Officer

The provisions of Georgia Code Section 50-8-80 et seq. require that the Commission, before the 15th day of December each year, adopt a budget and work program for the succeeding calendar year. Once adopted, the 2024 Budget and Work Program will be the Commission's official policy regarding allocation of the Commission's money and staff resources during 2024. The Proposed 2024 Budget and Work Program was shared with the Board on October 25, 2024. On November 8th, the Commission has an opportunity to discuss and adopt the budget.
