


FY 2020-2025 TIP Amendment #5

Joint TAQC/ARC Board Meeting May 11, 2022 MPO Role and Responsibility

 ARC is designated as the Metropolitan Planning Organization (MPO) for the Atlanta region

- MPO area is federally mandated for populations over 50,000 people
- Implements comprehensive, coordinated, and continuous transportation planning at the regional level
- 20-county Atlanta MPO area
 - 13 full counties
 - 7 partial counties





Role of the Transportation & Air Quality Committee (TAQC)

- TAQC serves as the MPO policy committee
- Review and approve the Regional Transportation Plan (RTP), including all modes of transportation:
 - Must be "financially constrained." The plan cannot have more in project costs than are forecast to be available.
 - Cannot violate federal air quality requirements.
- Maintain a shorter-range (6 year) Transportation Improvement Program.
- Approve an annual Unified Planning Work Program (UPWP).
- Review and take action on policies and special plans covering a wide variety of transportation topics (safety, transit, etc.).

Infrastructure Investment and Jobs Act


- IIJA signed into law on November 15th, 2021
- FHWA began releasing funding allocation tables in mid-December 2021
- MPO suballocation tables released in late February 2022
- MPO suballocation included significant additional funding for existing FY 2022 programs reauthorized by FAST act; new Carbon Reduction Program funding
- Amendment needed to authorize additional funds ahead of FY 2022 closeout







FAST Act - IIJA Program Funding Levels

- Estimates shown assume a two-percent growth rate
- STBG program growth averages around 10 percent over the lifespan of the current TIP; about 98 percent for TA
- CRP program is new for IIJA







What's in Amendment #5

- Additional fiscal year 2022 funding to transportation improvements in the TIP
 - Roadway state-of-good-repair improvements
 - Transit amenity and access improvements
 - Pilot transit electrification program
- General cost estimate increases to federal-aid projects beyond threshold for an administrative modification

Amendment #5 Highlights

- New pilot program for regional bus and bus facilities electrification (AR-064-2022)
 - Provides \$11.8M to fund electrification infrastructure for transit operators through the IIJA Carbon Reduction Program
 - Projects selected via competitive application process
 - Administered jointly through ARC ATL partnership
- MARTA clean bus procurement (M-AR-274B2)
 - Provides \$12M to fund the purchase of approximately 22 new Compressed Natural Gas buses
 - Maintains state of good repair for MARTA's clean bus fleet



Amendment #5 Highlights (cont.)

- Americans with Disabilities Act (ADA) improvements throughout Cobblinc system (CO-476)
 - Provides \$11.5M to fund ADA improvements in and around Cobblinc bus stops, transfer centers and related facilities
 - Will improve access and safety for all Cobblinc customers
- MARTA Clayton Transfer Center Upgrades (M-AR-453)
 - Provides \$9.6M to improve customer experience at county's major service hub
 - Will add/improve fare media machines, bathrooms, waiting areas, shelters, parking and bus routing updates



Amendment #5 Highlights (cont.)

- GDOT Bridge Upgrades
 - Provides \$12.6M to replace deficient bridges in Barrow, Dawson and Walton counties
- SR 6 Truck Friendly Lanes
 - Allocates \$34M over TIP and RTP to facilitate the safe movement of truck traffic through the SR 6 logistics corridor
- SR 92 Continuous Flow Intersection at South Fulton Parkway
 - Applies \$14M to improve safety by reducing left turn conflicts at busy intersection in the City of South Fulton

Amendment 5 Schedule

- 10-day Public Comment Period May 5 to May 18
 - Public Hearing Wednesday May 11 (TAQC meeting)
- Proposed Committee and Board Action
 - TCC June 3
 - ARC Board & TAQC June 8
 - GRTA Board June 8
- Submit documentation to US DOT (FHWA & FTA) and US EPA for approval mid-June
- Conformity Determination expected mid to late-June
